WE ARE A FAST PACED COMPANY THAT ONLY WANTS TO MAKE LIFE FASTER AND SIMPLE, SO THAT WE HAVE MORE TIME TO FOCUS ON THE PEOPLE WE SERVE DAILY. THIS IS WHY WE REQUIRE AN ELECTRONIC SIGNATURE FROM OUR CLIENTS. IF YOU WOULD LIKE TO RECEIVE A COPY OF ANY DOCUMENT/S THAT YOU HAVE SIGNED, PLEASE MAKE THE REQUEST AFTER YOU HAVE COMPLETED THEM AND A COPY WILL BE EMAILED TO YOU DIRECTLY. REMEMBER THAT IF YOU DO NOT REQUEST ON THE DAY OF PAPERS BEING RETAINED, (YOU WILL BE REQUIRED TO SUBMIT A RECORDS REQUEST). FEES MAY BE APPLICAPABLE FOR THE ADDITIONAL SERVICE.

"BY SIGNING THIS FORM" YOU SOLELY AGREE THAT YOUR SIGNATURE HAS BEEN RECORDED FROM YOU, THE RECIPIENT OF THE SERVICE AND AUTHORIZE THE COMPANY REPRESENTATIVE TO RETAIN YOUR SIGNATURE ON DOCUMENTS AS A RECEIPT OF SERVICES FOR AUTHORIZATION AND VERIFICATION PURPOSES. IT IS ALSO YOUR RIGHT TO REQUEST THAT WE SEND ALL FORMS THROUGH THE MAIL BUT THIS MAY MAKE THE REQUEST VOIDED IF YOU DO NOT HAVE ENOUGH TIME PRIOR TO YOUR APPOINTMENT DATE TO FILL THEM OUT AND SEND BACK.
